

ObamaCare . . . Another TAX we can't afford

Promises Broken:

- **“Universal coverage for the 46 million uninsured Americans.”** ObamaCare spends \$1 trillion to get people covered, yet as many as 30 million Americans may be uninsured. (Source: CBO estimate 3/10 & 6/12)
- **“You can keep your current health insurance.”** ObamaCare gives incentives to employers to drop employees' insurance plans to save money.
A large number of small business owners are likely to drop health care insurance for employees because the penalty tax is much cheaper. (Source: House Ways & Means)
20 million Americans may no longer have their current employer-based health coverage by 2019. (Source: CBO Projection 6/12)
645 thousand Americans could lose current health care insurance. (Source: Deloitte CPA by House Ways & Means Report)
- **The Costs of ObamaCare have already DOUBLED from its original estimates.** (Source: House Ways & Means Committee Notes)

The Reality - Increased Costs:

- **Family of 4 will pay \$1250 per month for health insurance!** (Family of 4 health care insurance with lower priced “Silver” option via State Exchanges (Source: American Enterprise Institute, S. Gottlieb 5/8/12)
- **A 30 year old single who makes \$50k/yr will be tempted to simply pay \$1,250/yr ObamaCare tax rather than the typical \$10k/yr for insurance premiums. The result? Health care costs will increase for everyone.** (Source: House Ways and Means Committee)
- **A government board will be authorized to restrict treatment and services**

The Reality - Lost Jobs:

- **72% of small business owners say ObamaCare makes it harder for them to expand and hire more employees.** (Source: House W&M data)

The Reality - Lost Liberties:

- **Effective 8/1/12 ObamaCare forces many healthcare employers, regardless of their religious or moral convictions, to offer abortion-inducing drugs, sterilization and contraception.** (Source: Affordable Care Act aka ObamaCare)
